Chairman, Circle Disaster Management Committee may invite any other official of other department for its meetings as Special Invitee.

Duties and Responsibilities of CDMCs:

- I. Provide technical and professional support to the VLMCCs for the preparation of Village Master Plan for Disaster Management.
- II. Design and implement awareness generation activities on Disaster Management.
- III. Review and Monitor the preparedness of Govt. departments and agencies on Disaster Management.
- IV. Provide feedback to the DDMA and extend cooperation to it in implementation of Disaster Management activities.
- V. Plan, implement and monitor relief and rehabilitation operations.

CDMCs should normally meet once in two months and as many times as may be required during times of disaster.

Minutes of every meeting of CDMCs should be recorded and shared with DDMA.
