Minutes of the 46th SEC Meeting held on December 6, 2022 in the Conference Hall of Chief Secretary, Assam, Janata Bhawan, Dispur.

The Chief Secretary & Chairperson, State Executive Committee (SEC) of ASDMA chaired the meeting. He welcomed the members present and asked the Chief Executive Officer, ASDMA to present the agenda of the meeting for discussion.

The first meeting of the 46th meeting of SEC was held on November 4, 2022. The first four agenda items were discussed in that meeting and minutes of the meeting were circulated among the members with approval of the Chief Secretary & Chairperson, SEC.

The remaining agendas starting from agenda item five as follows were discussed in the 2nd meeting of the 46th SEC on December 6, 2022.

Agenda Item: 5. Status of allocation and utilization of SDRMF (SDRF + SDMF) fund for the year 2022-23

Resolution: The SEC took note of the status of allocation and utilization of SDRMF (SDRF + SDMF) fund for the year 2022-23 given in the agenda note.

Agenda Item: 6. Information related to essential commodities and GR items provided through Indian Airforce during flood season 2022-23

Resolution: SEC took note of the details of essential commodities and GR items airlifted from Guwahati and Jorhat to the Flood and Landslide affected districts-Cachar and Dima Hasao since May 2022.

Agenda Item: 7. Approval of the draft Guidelines on constitution and administration of the Assam State Disaster Mitigation Fund 2021-22 to 2025-26.

Resolution: SEC asked ASDMA to follow the guidelines on administration of the Disaster Mitigation Fund 2021-22 to 2025-26 as notified by the Ministry of Home Affairs, Government of India vide No. 33-02-2020-NDM-I dated January 14, 2022. SEC also asked ASDMA to revisit the draft guidelines prepared for constitution and administration of the Assam State Disaster Mitigation Fund 2021-22 to 2025-26

and incorporate only those aspects where the central guidelines authorizes the State government to incorporates its own norms etc.

Agenda Item: 8. Approval of the Scale in respect of Sanitary Napkins which was included as relief item during 2021

Resolution: SEC approved the scale of 2 packets of sanitary napkin per women as a scale of GR item when entering the Relief Camp and temporary shelter.

Agenda Item: 9. Approval for re-appropriation of fund for upgradation of existing 1077 District Disaster Management Toll Free Services in 28 DDMAs and the newly created DDMA Bajali through BSNL

Resolution: The Chairperson, SEC asked ASDMA to place the matter in the next meeting of the SEC with necessary details.

Agenda Item: 10. Approval to the revision of Terms of Reference (ToR) for the post of Field Officer (DM) posted at Revenue Circle and Project Officer (DM) posted in 16 departments

Resolution: The Chairperson, SEC asked ASDMA to place the matter in the next meeting of the SEC with detail note regarding utilization of man power at times of disasters and at other time and details of performances review mechanism.

Deputy Commissioners & SDOs (C) during 2022-23 as per agenda note.

Agenda Item: 16. Ex-post facto approval to Rehabilitation Grant released to the Deputy Commissioners during 2022-23 till October 2022

Resolution: SEC accorded ex post facto approval for an amount of Rs. 13917.338 lakh released by the Revenue & DM Department as an advance to the Deputy Commissioners during 2022-23 as per agenda note.
