
**ORDER**

No. ASDMA.28/2021/ 217

Dated 13<sup>th</sup> August, 2021

In partial modification of the order issued vide No. ASDMA.28/2021/173 dated 13<sup>th</sup> July, 2021 regarding conduct of recruitment and entrance examinations for higher education, the following directives have been issued:

1. Recruitment / entrance examinations are permitted across the State with strict adherence to COVID-19 protocols including observance of COVID appropriate behaviour by all concerned.
2. The examinations should be conducted with 50% of seating capacity of the examination hall or 50 candidates whichever is lower.
3. Not more than 300 candidates should be allowed to take examination at any center in a shift.
4. Such candidates appearing in the said examinations will be exempted from the restrictions on inter-district movement, movement during curfew hours, odd-even formula of vehicular movement in urban and rural areas on production of valid admit card.
5. Candidates have to wear masks and maintain COVID appropriate protocol at all times.
6. In the entry point, the candidates should be screened with a thermal scanner and only asymptomatic candidates shall be allowed to enter exam premises.
7. The examination halls shall be suitably sanitized before and after exam process.
8. Hand sanitizers should be kept in the entry point of the examination hall for candidates and Examiners / Supervisors as per requirement.
9. A written instruction may be issued to the candidates to be careful in the preceding days of the examination to avoid contact with COVID positive persons.
10. All symptomatic candidates can be seated at a distance in a separate room/hall in each centre to be kept vacant for such purposes. In such halls, the invigilators may be provided all protective material like masks, face shield, PPE kits and gloves with sanitizers.
