**Essential Qualification:**

1. A candidate should be a citizen of India and must have registration in the Employment Exchange of Govt. of Assam.
2. Age of the applicant should not be below 21 years and above 43 years as on 01.01.2023.
3. A candidate must possess a valid Transport License for Light Motor Vehicle (LMV) / Heavy Motor Vehicle (HMV).
4. A candidate should be H.S.L.C. Examination pass from any Examination Board / Council recognized by Govt. of Assam.
5. Preference will be given to candidates having Driving Experience in any Government establishment for which proper experience certificate has to be furnished from the Govt. establishment where the candidate has served.
6. Medical fitness (eye/ear) by a Government Doctor.

**Duties and responsibilities:-**

1. Practicing safe driving habits.
2. Following all state and national safety regulations and standards.
3. Accurately following routes, maps, and directions.
4. Opening vehicle doors and assisting passengers/loading cargo/loading baggage.
5. Keeping exterior of vehicle clean and presentable.
6. Maintaining vehicle equipment; replacing oil, filling gas tank, general motor vehicle maintenance as needed for safety.
7. Cleaning windows, windshields, and mirrors as needed.
8. Keeping interior of vehicle clean of debris and clutter.
9. Loading and unloading vehicle.
10. Collecting payments, documenting amount, and offering receipts.
11. Completing documentation such as logs, mileage or cargo and passenger reports.
12. Following schedules and rerouting in timely manner when faced with traffic or congestion.
